Certainty level - 80-95%

- In advanced development or integration testing
- High confidence about release date

Next

Certainty level - 60-70%

- May be in progress
- Good understanding of requirements and design
- Likely don't know exact release date
- May change based on feedback, market conditions, other priorities

Later

Certainty level - 30-40%

- Areas of investment that will be prioritized, may not know exact use cases
- > No confirmed timeline
- Will change based on research, validation, and market conditions

Releases happen every month, quarterly planning determines what work happens next, company goals set the strategic areas of investment.


Accessibility remediations - student interfaces






LTI 1.3 improvements and documentation

Qualitative Rubrics that can be marked


Currently, a qualitative Rubrics allows the grader to provide a qualitative mark (excellent, bad, ...) to different criteria of a question. However, it does not allow the grader to provide a mark to the question as a whole.

Offline Annotations

Graders must be able to download the documents uploaded by the candidates, make annotations to it offline (using their own tools) and the upload the annotated version to be shared with the candidates.



Limit back navigation

Supports a variety of configurations such that a scenario like this is supported:

Test-takers can only proceed through the entire test in a linear fashion, answering the questions in sequence. They are unable to navigate freely between questions or sections in the test.
